## **ALAN ELLIS**

**Alan Ellis**, past president of the National Association of Criminal Defense Lawyers and Fulbright Award recipient, is a nationally recognized authority in <u>sentencing</u>, prison matters, <u>appeals</u>, <u>2255</u> motions and <u>international prisoner transfers for foreign inmates</u> with offices in San Francisco and New York. He has been practicing law for 50 years.

Alan and his law firm endeavors to obtain for its clients the lowest possible sentence and if it is one of incarceration placement, the best prison possible with release at the earliest opportunity through prison programming, appeals, 2255 motions and international prisoner transfers for foreign inmates.

He is co-author of the <u>Federal Prison Guidebook</u>: <u>Sentencing</u> and <u>Post-Conviction Remedies</u>. He also publishes three quarterly e-newsletters with a combined readership of over 18,000 judges, lawyers, prosecutors and U.S. Probation Officers: <u>Judicial Updates</u>: <u>Views from the Defense</u>, <u>White Collar Updates</u> and <u>Alan Ellis's Updates</u>.
